

Fall 2025 Flash Sweepstakes Rules

Eligibility: NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The Sweepstakes (the “**Sweepstakes**”) is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least twenty-one (21) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of KCRW Foundation (“**Sponsor**”), Santa Monica College, or prize suppliers and their parent, affiliates, partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies (“**Sponsor Parties**”), and the immediate families or household members of each. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

How to enter: The Sweepstakes begins at 12:00 am PT on September 13, 2025, and ends at 11:59 pm PT on September 29, 2025 (“**Sweepstakes Period**”) and comprises a series of separate daily entry/drawing periods as defined in the “Selection of Winners” rule below. Any eligible individual who donates \$25 or more to KCRW during the Sweepstakes Period will automatically be entered into the Sweepstakes drawing. All current monthly members are automatically entered. Purchase does not increase the chances of winning. To enter without a donation, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code at form.kcrw.com/sweepstakes-entry. The date and time of the submission defines the drawing into which a submission will be entered. Regardless of the method of entry, only one (1) entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

Prizes: One (1) prize is available per Sweepstakes Period. Odds of winning depend on the number of eligible entries received during Sweepstakes Period.

Day #1-2:

The sweepstakes starts 12:00 a.m. PT on September 13, 2025 and ends at 11:59 p.m. PT on September 14, 2025.

Prize: One (1) winner will receive a (4) person box at the Hollywood Bowl to see Devo & B52s on 10/19/25 (ARV \$804).

Day #3:

The sweepstakes starts 12:00 am PT on September 15, 2025 and ends at 11:59 pm PT on September 15, 2025.

Prize: Limited-edition TRAN2A 6LP box set and a Cambridge Audio CXN100 digital music player. (ARV \$1,249)

Day #6-7:

The sweepstakes starts 12:00 a.m. PT on September 18, 2025 and ends at 11:59 p.m. PT on September 19, 2025.

Prize: One (1) winner will receive (4) premium tickets, VIP lounge access, and parking at the Greek Theatre to see TV on the Radio on 11/16/25 (ARV \$558).

Day #10-11:

The sweepstakes starts 12:00 a.m. PT on September 22, 2025 and ends at 11:59 p.m. PT on September 23, 2025.

Prize: One (1) winner will receive a special dinner for four (4) to Kato, a Michelin-star Omakase-style Taiwanese restaurant helmed by chef Jon Yao. Includes a choice of traditional wine or alcohol free pairing for each guest. Diners will also take home a bottle of Kato's exclusive wine collaboration with Cole Ranch (ARV \$1,000).

Day #13:

The sweepstakes starts 12:00 a.m. PT on September 25, 2025 and ends at 11:59 p.m. PT on September 25, 2025.

Prize: One (1) winner will receive four (4) VIP passes to Future Ruins festival on 11/8/25 at the Los Angeles Equestrian Center. Ticket includes dedicated VIP fast lane entry, VIP gift bag, access to VIP village which includes elevated platform with view of the main stage, complimentary hors d'oeuvres and select beverages available within the lounge (3:00 pm - 6:00 pm), air conditioned restrooms, premium food and bar offerings, and more. (ARV \$2,020).

Day #15-16

The sweepstakes starts 12:00 a.m. PT on September 27, 2025 and ends at 12:00 p.m. PT on September 28, 2025.

Prize: One (1) Samsung 65" Class U8000F Series Crystal UHD 4K Smart TV (ARV \$500).

Day #17

The sweepstakes starts 12:00 a.m. PT on September 29, 2025 and ends at 12:00 p.m. PT on September 29, 2025.

Prize: One (1) \$900 Apple gift card to purchase the new iPhone 16 (ARV \$900).

Prize consists of only those items specifically listed as part of the prize.

Except where prohibited, potential winner must sign and return, within 15 days of being notified, the Affidavit of Eligibility, Release of Liability, and Prize Acceptance issued by Sponsor as well as a completed W-9 tax form as a condition to be declared the final winner and claim the Prize. Winner may be notified by telephone, mail or e-mail on or about August 18, 2025, and will be given instructions on how to claim the Prize. Winner will be required to sign and return an affidavit of eligibility and liability release (and, where permitted a publicity release) within five (5) days. Failure to comply when requested may result in disqualification and selection of an alternative potential winner. There is a limit of one (1) prize per individual/household per year from the Sponsor. If a potential winner is disqualified for any reason, Sponsor will award the applicable Prize to an alternate winner by random drawing from among all remaining eligible entries.
