

Fairmont Sweepstakes Official Rules

MATERIAL DEFINITIONS AND DETAILS

Applicability of Material Definitions And Details. These Official Rules (“**Rules**”) govern multiple separate and distinct sweepstakes campaigns (each a “**General Giveaway**” and collectively, the “**General Giveaways**”). For each individual General Giveaway, the specific material terms—including the **General Giveaway Period**, **Prize description and value**, and **relevant dates and deadlines**—are set forth in the Material Definitions and Details section below corresponding to the name of the General Giveaway for which you submitted or plan to submit an entry.

The defined terms used throughout the remainder of these Rules shall have the meanings specifically assigned to them in the Material Definitions and Details section applicable to your specific General Giveaway. GENERAL TERMS AND RULES

Eligibility: NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR CONTRIBUTION WILL NOT IMPROVE AN INDIVIDUAL'S CHANCE OF WINNING. The General Giveaway is open only to all legal U.S. residents (except residents of FL, NY, and RI) who are at least 21 years of age, except employees, directors, and officers (or any persons who have been employees, directors or officers in the past 12 months) of Sponsor or Sponsor Parties and the immediate families or household members of each. The General Giveaway is subject to all applicable federal, state, and local laws and regulations. Void where prohibited or restricted by law or regulations.

How to enter: To enter the General Giveaway, submit your full name, email address, complete address with zip code, date of birth, and phone number with area code during the General Giveaway Period at the Entry URL or via the KCRW App by navigating to the “Win” tab and selecting the desired General Giveaway. The date and time of the email defines the date of entry and the drawing into which an emailed entry will be entered. Regardless of the method of entry, only one entry per person/per household per day will be allowed. Duplicate entries for the same day will be disqualified. All entries become the property of Sponsor and will not be acknowledged or returned.

Selection of Winner:

For the General Giveaway, one winner will receive the applicable Prize. The winner will be determined in a random drawing on or about the Drawing Date set forth above (from among all eligible entries received). The odds of winning depend on the number of eligible entries received. Sponsor’s decisions are final and binding in all matters relating to the General Giveaway.

The winner may be notified by telephone, mail or email on or about the Winner Notification Date set forth above and will be given further instructions on how to claim the Prize. The Prize must be redeemed by the Redemption Date set forth above in accordance with the Redemption Instructions set forth above.

Except where prohibited, the winner must agree to and accept, within 5 days of the Winner Notification Date, the provided Affidavit of Eligibility and Release of Liability. If a winner fails to accept and agree to the foregoing documents within the required time period or is disqualified for any other reason, the Prize will be forfeited, and a substitute winner will be selected by random drawing from among all remaining eligible entries. Only 3 alternate drawings will be held per Prize, after which the prize will remain un-awarded.

Winning Limits: Sponsor hosts various giveaways and sweepstakes, including the General Giveaway. If you are a KCRW monthly member, there is a limit to enter and win one “general giveaway” prize and one “member exclusive giveaway” item every 14 days. If you are a KCRW annual member, there is a limit to enter and win one “general giveaway” prize and one “member

exclusive giveaway” item every 30 days. If you are not a KCRW member, there is a limit to enter and win one “general giveaway” prize every 90 days.

Prizes:

The final winner will be responsible for all expenses (including, but not limited to, travel, accommodations, and expenses, if applicable in connection with Prize) not specifically included herein, and all applicable federal, state and local taxes. Form 1099-MISC will be issued to winner for the total approximate retail value of the Prize received, and winner must provide a completed IRS Form W-9 and valid government-issued photo identification prior to Prize fulfillment. Sponsor reserves the right to withhold applicable taxes from Prize value if required by law. The final winner acknowledges that acceptance of the Prize may result in significant tax liability and should consult with a tax professional regarding tax implications.

The Prize is non-transferable and no substitution by winner is allowed. Sponsor reserves the right to substitute prize for one of equal or greater value; otherwise, the Prize consists of only those items specifically listed as part of the Prize.
